Breckenridge Pharmaceutical has entered into a multi-product agreement with MSN Laboratories under which Breckenridge and MSN expect to commercialize several new ANDAs.

Under the terms of the agreement, MSN will develop, manufacture, and supply the products exclusively to Breckenridge for the U.S. market, and Breckenridge will market and distribute the products under its label.

Breckenridge and MSN have agreed to develop an oral antibiotic with current U.S. brand sales of \$644 Million USD, and a cardiovascular drug with current U.S. generic sales of \$35 Million USD.

This agreement contemplates the filing of multiple first-to-file Paragraph IV ANDAs.
